OF THE

1. NAME : The name of the Society is :
BROTHERS OF ST. GABRIEL EDUCATION SOCIETY.
2. ADDRESS: The registered Address of the Society shall be :
MONTFORT HOME, PATNA- 200010, BIHAR.
3. OBJECT : The object or purpose for which the Society established:
EDUCATION : To diffuse social, Religious, Secular, Scientific Knowledge and to inculcate Social, Moral and Religious values.


AND for the affore-said:

TO ESTABLISH: To establish, construct, organise, conduct, consolidate, support, develop, acquire, extend, maintain, close down, dispose of schools, manage and administer educational Institutions in all their branches meant solely for the purpose of education and not the purpose of profit.

- b) TO STAFF : To engage and remove professors, headmasters, schoolmasters, teachers, prefects, tutors, specialists, games, superintendents, specialists and managers, secretaries, accountants, clerks, servants and work-men and others and to pay salaries, wages, gratuities and pensions.
- c) TO PROVIDE: To provide residential accommodation, equipment and maintenance either free or for consideration.

d) SUCCESSION : To have perpetual succession by its corporate name .

e) TO ACQUIRE: To the extent as natural persons might or could do to acquire by purchase, lease, mortgage, loan, gift, grant, legacy, bequest, exchange, right, privilege, or otherwise from any person, company, society, government, or institution or body whatsoever and to hold all or part of the movable and immovable properties of all descriptions now or here-after vested in or in the possession of the Provincial of the Brothers of St. Gabriel, or now or here-after vested in or in the possession of any person or body and used or devoted for or to any purpose of the Society or any Charitable, educational, social, moral, cultural, religious, scientific or other purposes whatsoever in connection therewith and to have the name or names of any or all of the above named mutated in any court or office (civil, revenue, municipal, estate) or any other nature to that of the Society.

f) TO BUILD : To erect school buildings, dormitories, hostels, chapels, orphanages, bungalows, play-fields, stadiums and any other type of building or structure whatsoever

to further any purpose or purposes of the Society and to maintain, deal with, manage, control, administer, develop, improve, repair, demolish or reconstruct the same or any portion or portions thereof.

g) TO TAKE GIFTS : To take or receive from any persons, government, institutions or body whatsoever, any gifts whether money or property, movable or immovable such as real Estate or donations

in the form of debentures, Stocks, Bonds or Secretaries in any company or association, whether incorporated or not or whether by the gifts of a person living, or by legacy, bequest, will or foundation, whether subject to any special trust or not, for

any one of the objects of the Society; moreover, to take such steps by way of written appeal, public meetings, or otherwise for securing of such contributions to the funds of the Society as may be deemed fit, and to accept the office of and to act as trustees, managers, or administrators, whether solely or or jointly with others, or another for, or in respect of, any gift or any property movable or immovable, whether vested wholly or partially in the trustees of the Society or otherwise, whether subject to any trust and notwithstanding that the carrying out of such trusts, managements or administrations would involve the exercise by the Society of the powers not specifically mentioned in these presents.

h) TO ALIENATE : To alienate by way of sale, mortgage, lease, release loan, change, hypothecate, pledge, exchange, hiring out, gift, or otherwise, with or without security the properties of funds of the Society or any portion or portions thereof including the making or giving of subscriptions, contribution, or assistance-pecuniary or otherwise to charitable, educational, ecclesiastical, religious, benevolent, or other institutions, bodies, or persons as from time to time may seem necessary or appropriate within the prescriptions of Canon Law and according to the Constitutions regulating to the alienation of the properties of the Religious Congregation of the Institute of the Brothers of St. Gabriel.

i) TO INVEST : To invest, lay aside, deposit in banks, or otherwise deal with the moneys or funds of the Society not immediately required for the objects of the Society and to subscribe for, purchase, acquire, hold, sell, endorse, and negotiate in every way debentures, stocks, shares, and securities of every description on the money market.

j) TO RAISE FUNDS : To borrow and to raise funds with or without security in any manner the Society may think fit and to repay the same.

k) TO NEGOTIATE : To negotiate with and to enter into arrangements with any Government or authority whether Supreme, State, District, Municipal, University,

or other public or private body as may seem conducive to the promotion or accomplishment of the objects of the Society or any of them; and to apply for, obtain, collect, receive or recover from any such Government or authority or body such grants, allowances, rights, concessions, and privileges, as may seem, from time to time, desirable and to carry out, exercise, comply with and utilise the same.

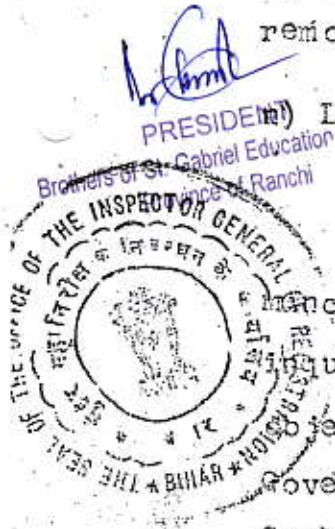
l) TO USE THE INCOME : To use all the income from the property, movable or immovable or from the works of the Society as such, whensoever derived, for the objects of the Society as set in this Memorandum of Society, but to distribute no portion thereof among its members by way of profits, dividends or bonuses

m) BANKS : To open and to operate on current, overdraft, or fixed deposit accounts with any banks in the name of the Society upon such terms and in such manner as the Governing Body shall deem fit and to appoint or remove those who operate on such accounts, and moreover, to open branch accounts with any Bank or Banks in the name of the Managing Committee or departments or heads of Institutions controlled by the Governing Body of the Society and to appoint or to remove those who operate on such accounts.

n) LAWSUITS : To commence, prosecute, defend, appear to conduct, continue, compromise, abandon, contest, or submit to any civil, criminal, administrative, revenue, Municipal arbitration, conciliation, or other proceeding or to inquire for the furtherance of or in conjunction with any of the objects of the Society; and to appoint such persons as the Governing Body deem fit for the purpose of representing the Society or any managing committee or Member of the Society in any legal or other proceeding that may from time to time be instituted by or against the Society or such managing committee or person.

o) SIGNING : To determine the manner in which notes, receipts, acceptance, discharges, endorsements, cheques,

release, agreements, contracts, and other documents (except such as related to the alienation of properties provided for in Regulation No above shall be signed and executed by and on behalf of the Society; and to make, execute and give the same.

p) COMMITTEES : To act as the managing committee of or to dissolve managing Committees composed of Members of the Society alone, or together with non-members for each institution, ~~the~~ school, high school, controlled by the Governing Body of the Society and to appoint the respective principal or Manager to represent the Governing Body in the ordinary day-to-day management of the said institution.

q) DELEGATE: To delegate any of its powers to committees consisting of such Member or Members of their body, including the Members of the Governing Body and non-members of the Society as the Governing Body shall see fit, and any committees so formed shall, in the exercise of the powers so delegated, conform to any regulations that may be imposed upon it by the Governing Body; but nothing in these presents shall be construed in such manner as to give such committees any power of management over the Society, which power is exclusively vested in the Governing Body of the Society and the said Governing Body may at any time withdraw any powers so delegated to such committees.

r) PRESIDENT : To do all things and everything necessary, suitable and proper for the promotion or accomplishment of any of the purposes or objects of the Society or for the furtherance of any powers set forth in these presents either alone or in conjunction with other societies, corporations, firms, or individuals, and to do every act or acts, thing or things incidental or appurtenant to or growing out of or connected with the aforesaid business or powers or any part or parts thereof provided the same be not inconsistent with the constitutions of the Society of Brothers of St. Gabriel nor the Canon Law of the Catholic Church, nor with the laws under which this Society is organized ; and subject to the provisions of these presents, the Governing Body may exercise all powers of the Society which are not by any law nor by these presents required to be exercised by the President the Vice-President or by the Society in General Meeting.

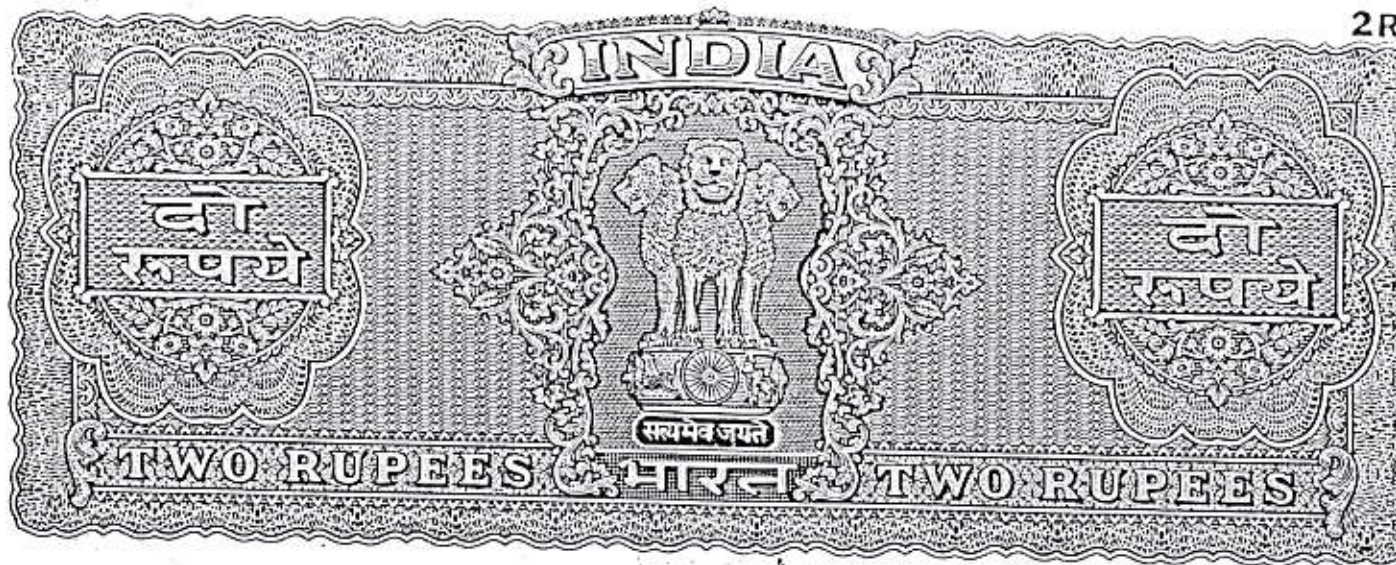

PRELIMINARY: In these presents , unless repugnant or inconsistent with the context , words , terms , or expressions defined in the Societies ' Registration Act XXI of 1860 or in any statutory modification in force at the date at which these Rule and Regulations become binding on the Society , shall have the meaning so defined , and words importing the singular shall include the plural and 'Vice versa' and words importing persons shall include bodies corporate , and words , terms , or expressions having a religious or ecclesiastical bearing shall have the meanings attributed to them in the

Law of the Catholic Church and in the Constitutions of the Society of the Brothers of St. Gabriel , particularly , the following words or terms shall bear the meanings set opposite to them in the second column thereof :

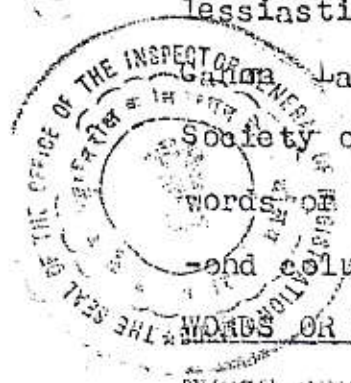

Gabriel who has been duly appointed Acting head of such religious province or territory during the serious illness or prolonged absence from territory of the provincial , vice provincial , or superior Regular as the case may be . That Religious Society known the brothers of St. Gabriel, as established by the Holy See.

CONSTITUTION : The laws and regulations of the society of Brothers of St. Gabriel.

CANON LAW : The Law of the Catholic Church .

CATHOLIC : Of or pertaining to persons, bodies or institutions of that Church which regards the pope of Rome as its Spiritual Head , or a member of such bodies or institutions .

A DIRECTOR : That member of the Society of the Brothers of St. Gabriel, who is duly appointed as the Local superior of an Institution.

A COUNCELLOR : That member of the Society of the Brothers of St Gabriel who is duly appointed as advisor or consultant to the Provincial .

1. NAME : The name of the Society is : The Brothers of St. Gabriel Education Society.

2. OBJECTS : The object and purpose for which the Society is established are stated in paragraph Number 3 of the memorandum of the Society .

3. MEMBERSHIP : : The number of members of the Society , including the Governing Body , shall not be less than ten . The same members shall be appointed by the president , for the time being, of the Society, and the entry of an eligible person's signature along with the counter-initials of the President in the membership Book of the Society ' ipso facto' be deemed conclusive proof of such member's appointment and admission into the Society and shall debar and member or non-member or body (other than the president) from cancelling or disputing such appointment or membership or the exercise of the powers thereby given or from questioning

the same in any court whatsoever, such members may be suspended, retired, or expelled from the Society by the said president without assigning any reason for such action, and the cancellation or deletion of such signatures in the membership rolls substantiated by the initials of the president shall be deemed conclusive proof of such member's resignation, retirement, suspension, or expulsion from the society and shall debar such persons or any member or non-member or body from disputing or questioning the same in any court whatsoever.

MEMBERS : Only members of the Religious Society of the Brothers of St. Gabriel, are eligible as members of the Society.

5. FEES : No fees, subscriptions, or contributions whatsoever shall be paid by or shall be assessable on the members of the society as such.

6. Area of operation : All over India.

6.* TITLES * DEEDS * EXECUTION:

a) All properties, movable and immovable of the Society shall vest for the time being, for the use of the Governing Body in accordance with the Rules and Regulations of the Society

b) All deeds, agreements, lease, release, mortgages or documents of whatsoever nature relating to or affecting the properties or interests of the Society, shall be taken and stand in the name of the society.

c) All deeds, agreements, leases, releases, mortgages or documents of whatever nature relating to or affecting the alienation of the immovable properties or rights or privileges of the Society shall be executed for and on behalf of the Society by the

Society by the president for the time being, of the Society or by his duly authorised Agent or Agents by a registered document of power of Attorney .

7. MANAGEMENT: The supreme control and management of the affairs and interests of the Society shall vest in the Governing Body consisting of seven members , viz: the president the Vice President and five other members who are duly appointed by the president and from among or others members , the President shall appoint and may remove from office at his discretion a Treasurer and a Secretary . The Vice President may be appointed also as Secretary , but not as Treasurer . The said seven members of the Governing Body , shall be the only ' ex officio ' members of the Society .

8. MANAGEMENT OF INSTITUTIONS : Every school , college or any other educational institutions established & owned and or administered by the Society , shall be in the category of a Religious minority Institutions as contemplated by Article 19 and 30 of the Constitution of India and as such the Principal / Headmaster shall be only the person who is a member of the Society of Brothers of St. Gabriel .

a) The members of the managing Committee of every school college or educational Institutions established , owned and or administered by the society , shall be appointed by the president or in his absence by the vice- president of the Society . The President Shall be the ex officio Chairman of the managing Committee of such Institutions .

b) The managing Committee of every school , College or educational institutions established , owned and or administered by the Society , shall have not less than three members nominated by the president / Vice president of the Society , in addition to the president / Chairman and the Secretary thereof and the members

so nominated may remain in office at the discretion of the President of the Society .

- c) The President or in his absence the Vice - president of the Society shall be competent to appoint the Principal / Headmaster , Secretary , manager , vice Principal , Staff and or Class IV employees of every educational institution established , owned or administered by the Society . He shall have the power to appoint , remove , dismiss , suspend any employee of the institution .
- d) The principal / Headmaster of every educational institution, established , owned or administered by the Society shall be ex officio Secretary of the managing Committee of the institution .

9. REWARD: The members of the Governing Body as such shall not receive any reward or remuneration whatsoever . If however , the members of the Society are appointed or engaged in any one of the works of the Society , they shall be entitled to receive Honoraris for professional services rendered , as teachers , supervisors , or holding any other office in the Society , as the case may be , and be entitled to maintenance , medical care and further training.

10. PRESIDENT : The president shall be that member of the Society of the Brothers of St. Gabriel , who , according to Constitution of the said society , shall be , for the time being , the duly appointed provincial , or acting Head , as the case may be of the religious Province or territory of the said society and the president shall exercise all such powers and do all such acts as may be necessary or convenient for the control of the general policies and over - all direction of measures for the promotion or accomplishment of the object of the Society, without prejudice to the generality of the

of the fore - going, the President:-

- a) Shall appoint members (other than 'ex officio' members) of the Society and the religious personnel of the Staffs of all Institutions working under the Governing Body of the Society ; and shall convene meetings of the religious staffs of such institutions , meeting of the Governing Body , and General meetings of the Society if and when he considers it necessary or advantageous to the interests of the Society to summon the same .
- b) Shall superintend the purchase , lease , mortgage , rental or acquisition in whatsoever manner and the selling , leasing , renting out , or the alienating in inwhatssoever manner of any or all immovable properties of the Society ,
- c) Shall contract for the erection of any new building or construction and for the extensive repair , alteration , or demolition , of existing buildings or structures .
- d) Shall have the power to determine , supervise and control the acquisition or alienation of immovable properties and the purchase or sale of extraordinary equipment , furnishings , machinery or other movable objects up to the value of twenty five thousand only (Rs. 25,000/=) without calling a meeting of the Society consulting the Governing Body but for the acquisition or alienation in any manner whatsoever of immovable properties to the purchase or sale of extraordinary objects or the expenditure more than rupees twenty five thousand (Rs. 25,000/=) for extraordinary purposes of whatever nature , a majority vote of duly summoned and constituted meeting of the Governing Body all members being present in person or by proxy , shall be required .
- e) Shall make an inspection of the institutions of the Society ordinarily once each year and ...

year add when emergencies arise, and shall examine into the needs and requirements of such institutions and the methods employed in carrying out the objects of the Society and shall make proper adjustments if and when they are required.

11. VICE- PRESIDENT: The vice - president shall be that member of the society and the first Councillor of the Provincial superior of the Society of the Brothers of St. Gabriel, duly appointed according to the constitutions of the said Society. In the absence of the President, he shall exercise all such powers and do all such acts as may be required for the routine management and control of all institutions working under the Governing Body of the Society.

12. TREASURER: The Treasurer is that member of the Governing Body appointed by the President as the accountant of the Society. He shall exercise all such powers and do all such acts as may be required for the proper conduct of the ordinary business administration of the properties, movable and immovable, of the Society under the general supervision of the president.

13. SECRETARY : The Secretary is that member of the Governing Body duly appointed by the President as such. He shall exercise all such powers and do all such acts as may be required for the proper conduct of the ordinary correspondence of the Governing Body, for the making of official reports and for the maintenance of the registers and files of the Society.

14. POWERS OF THE GOVERNING BODY: The Governing Body of the Society shall be empowered and is hereby authorised to do all those acts and THINGS ON BEHALF OF THE Society for which the Society has been formed, and which are listed in

15. CHANGES : (Upon the appointment of a qualified person to a GOVERNING BODY: position as the member of the Governing Body , he shall assume all powers , duties , responsibilities and privileges of the said position . When he is replaced by another person, by proper appointment , he shall lose all prerogatives and privileges attached to the position in the Governing Body ; but shall retain his membership in the Society .

16. VAVANCIES : (In the event of a vacancy occurring among the members GOVERNING BODY: of the Governing Body , such vacancies shall be filled by appointments , without delay . Also the revised list of the Governing Body shall be filed with the Secretariat, Inspector General of Registrar, New Secretariat, Patna .

17. VACANCIES: (In the event of vacancy occurring among the members OTHERS of the Society, other than those of the Governing Body, a new member shall be appointed by the President in consultation with the Governing Body .

RESOLUTIONS: (The President or in his absence the Vice-President SPECIAL may, from time to time, issue a presidential resolution in regard to any or all the ordinary powers granted to him in regulations Nos: 10 above or else where in these presents, and such resolutions shall have the validity, effect and full binding force of resolutions passed at a meeting of the Governing Body duly convened and constituted and such resolutions shall not be deemed invalid by reason of want of notice or from any other cause whatsoever

19. MEETINGS: (The members of the Governing Body may meet together GOVERNING BODY: for dispatch of the business of the Society, adjourn and otherwise regulate their meetings as they may think fit, observing however the following: -



a) **THE QUORUM** : The quorum necessary for the meetings of the Governing Body and for the transaction of the Governing Body, and unless so fixed shall be three Members of the Governing Body; one of whom shall be the president or the Vice-President. Provided that a resolution in writing or any document of whatsoever nature signed by a quorum of the Governing Body in accordance with the provisions of these presents shall be as valid and effectual as a resolution passed at a meeting of the Governing Body convened and constituted and such resolution shall ~~not~~ be deemed invalid by reason of want of notice, or vacancies for the time being in the Governing Body, or for any other cause whatsoever.

b) **CHAIRMAN** : The Chairman of the meetings of the Governing Body of the Society shall be the President, if present, otherwise the Vice President. No Chairman shall be elected.

c) **MAJORITY**: Questions arising at a meeting shall be decided by a majority of votes whether on a show of hands or at a poll; but in the case of an equality of votes the Chairman shall have a second or casting vote; provided, however, that no resolution of the Governing Body or of a Committee appointed thereby which pertains to the ordinary powers of the President as conferred by resolution No. 10 above or elsewhere in these presents shall be deemed to have carried or to have carried or to have any validity or effect whatsoever if the President shall have voted against it, and no such matter as pertains to the President's powers referred to above shall be taken up or be put a vote in any meeting at which the President is not present in person or by proxy; similarly, provided that no resolution of a meeting of the Governing Body or of a Committee appointed thereby which pertains to the ordinary powers of the Vice-President as conferred by Regulation No. 11 above or elsewhere in these presents shall be deemed to have carried or to have any validity or effect whatsoever if the Vice-President shall have voted against it, and no such matter as pertains to the Vice-President's powers

d) VOTES : At all meetings of the Governing Body or of any Committee thereof, every Member of the Governing Body or Committee whether present personally or by proxy and whether on a show of hands or at a poll have one vote only .

e) VOTINGS : At any meeting of the Governing Body or of a Committee appointed thereby, a resolution put to the vote of the meeting shall be decided on a show of hands of the Member present in person or by a duly authorised proxy and entitled to vote unless before the result of a show of hands a poll be demanded by the Chairman of the meeting or by a duly authorised proxy of the President or Vice-President or by at least two members present in person and entitled to vote and unless a-poll be so demanded a declaration by the Chairman of the meeting that a resolution has on a show of hands been carried by a particular majority or lost, or not carried by a particular majority, shall by conclusive proof of the number or proportion of the votes recorded in favour of or against such resolution .

f) COMPETENCY.: A meeting of the Members of the Governing Body for the time being, at which a quorum is present shall be competent to exercise all authority, powers and discretions by or under the regulations of the Society or the time being vested in the Governing Body generally.

MEETINGS : General Meetings of the members of the Society shall be convened for the handling of such matters as required to be determined by a General Meeting of the Society and such meetings shall be called and otherwise regulated by the Governing Body, observing however, the following:-

a) CHAIRMAN : The Chairman of the General Meetings of the Society shall be the President, if present, if absent, the Vice-President; provided that when

neither the President nor the Vice-President are present at an Annual General Meeting of the Society the members present shall elect a Chairman of the said meeting; but a Chairman may not be elected for other General said Meeting; but a Chairman may not be elected for other General Meetings.

b) QUORUM : The quorum necessary for the Annual General Meetings of the Society shall be those Members present at the Registered Address of the Society on the date set for such Meetings. The quorum, however, required for an extraordinary General Meeting for the alteration, amendment, addition to or revocation of any of the Articles of the Memorandum of Society or the Rules and Regulations of the Society, or for the amalgamation of the Society with another Society or for the division of the Society into two or more Societies, or for the dissolution of the Society shall be not less than three-fifths of the Members present in person or proxy.

c) ASSENT : The Assent of at least three-fifths of the members present in person or proxy shall be required in order to pass validity a resolution proposed at any General Meeting of the Members of the Society, provided that no resolution of a General Meeting or of a Committee appointed thereby shall be deemed to have carried or to have validity or effect whatsoever if the President, being present, shall have voted against it, or if the President, being absent from the said meeting shall have subsequently approved such resolution or proposition by signing the minutes of the meeting containing the said resolution.

(e) VOTING : At any General Meeting of the Members of the Society or of a Committee thereof, a resolution put to the vote of the meeting shall be decided upon by a show of hands of the Members present in person or by a duly authorised proxy and entitled to vote unless before the result of a show

hands, a poll be demanded by the Chairman of the Meeting or by a duly authorised proxy of the President or Vice-President or at least by two Members present in person and entitled to vote and unless a poll be demanded a declaration by the Chairman of the Meeting that a resolution has a show of hands been carried by a particular number of votes or lost, or not carried by a particular number of votes, shall be conclusive proof of the number of proportion of votes in favour of or against such resolution.

(f) COMPETENCY : A General Meeting of the Members of the Society duly summoned and constituted shall be competent to determine and decide upon, the division of the Society into two or more societies, or on the dissolution of the Society or on the amalgamation of the Society, wholly or partially, with another Society; and moreover, shall be competent to alter, extend, abridge or repeal any article of the Memorandum of Society or Rules or Regulations of the Society and to frame new articles or regulations for the same in accordance with the provisions of the Societies' Registration Act XXI of 1860 ; provided that no proposition shall be carried into effect unless a written or printed report of the Governing Body proposing the proposition shall have been delivered in person or sent by post to every Member of the Society at least ten days previous to the convening of the General meeting for the consideration thereof; nor unless such proposition shall have been assented to by the votes of at least three-fifth of the Members delivered in person or by proxy and confirmed by the votes of at least three-fifths of the Members present in person or by proxy at a second General Meeting convened at an interval of one month after the former General Meeting.

21. ANNUAL MEETING : Once every year, during the month of January or as near thereto as possible, there shall be summoned an Annual General Meeting of the Members of the Society to receive the annual report of the preceeding year's accomplishments or failures and to take up other such matters

22. EXTRAORDINARY GENERAL MEETING | The President or in his absence Vice-President of the Society may call an extraordinary General Meeting of the Society whenever it is necessary to do so.

23. NOTICES : | Notices of Meetings of the Members of the Governing Body or General Meetings of the Society may be given to Members thereof respectively in such manner as as may be decided from time to time by the Governing Body except as provided in Regulation No: 20 above

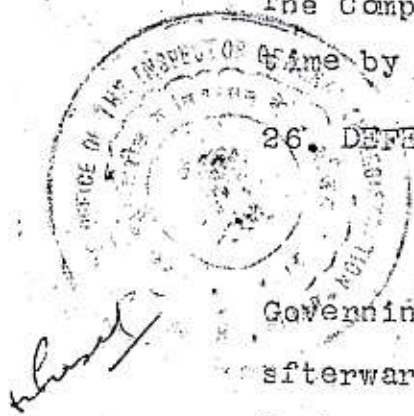
24. LAWSUITS | The Society may sue or be sued in the name of the President or such persons as shall be appointed from time to time by the Governing Body

25. S E A L | There shall be a common seal of the Society which shall be affixed at the discretion of the Governing Body to such deeds, contracts, agreements and official letters documents or statements of whatsoever nature as may require the sanction of the Governing Body . The The Composition of the said Seal may be altered from time to time by a resolution of the Governing Body.

26. DEFECTS | All acts done by any Member or by any meeting of the Governing Body of the Society or by any person acting as a ' bona fide ' Member of the Governing Body, shall notwithstanding that it be discovered afterwards that there was some defect in the appointment of such Members as aforesaid or that they or any of them were disqualified be as valid as if every such person or Member had been duly appointed and qualified.

27. AMENDMENTS OF MEMORANDUM OF ASSOCIATION AND RULES :

The Memorandum of Association of the Society and its Rules and Regulations and any rule and regulation hereafter made by

by the -Governing Body may from time to time be modified, added to, revoked re-enacted by a majority of not less than three fifth of the Society present at General Meeting called for the purposes provided that in case of any alteration abridgment or addition to the purpose of the Society or its amalgamation with another Society or the change of name of the Society, the provision of Section 12 and 124 of the Societies Regulation Act shall apply.

The Governing Body may frame business regulations for the better administration and Government of the Society from time to time provided these regulations are not repugnant to the Society or the present rules.

28. ANNUAL REPORT

After the Annual General Meeting of the Society, a copy of the current list of the Members of the Governing Body as constituted on the day of the said Annual General Meeting, giving the names, office(if any) occupation, and addresses of the Members of the Governing Body then entrusted with the Management of the affairs of the Society shall be sent to the Inspector General of Registration, New Secretariat, Patna, Bihar.

29. DISSOLUTION

If there should be a dissolution of the Society and it at that time any property or assets whatsoever should remain over the satisfaction of the debts and liabilities of the Society, the same shall not be taken to or distributed among the members of the Society or to or among any of them, but shall be given to some other Society of the Catholic Church, whether incorporated or unincorporated and whether registered or unregistered and the said Society shall be determined by the votes of not less than three fifths of the Members of the Society present or by proxy at a general meeting convened for the consideration thereof in accordance with the provision of the Societies Registration Act XXI of 1860.
